#### **DECREES**

### ART. 1 AVAILABLE PLACES

1. The competition for admission to the following degree course is open at this University for the academic year 2023/24.

In the registration procedure the candidate must express preferences by assigning a value from 1 (maximum preference) to 2 (minimum preference) to each *curriculum*.

# ART. 2 ADMISSION QUALIFICATION

1. The admission qualification is a school diploma or another qualification obtained abroad and recognised as suitable.

The admission qualification must be possessed at the time of confirmation of enrolment.

# ART. 3 APPLICATION FOR ADMISSION TO THE COMPETITION

- 1. Non-EU candidates residing abroad must submit the application for admission to the competition by 12.00 noon (CEST) on 18 May 2023 using the procedure provided on the University of Genoa's student portal <a href="https://www.studenti.unige.it/iscrizioni/preimmatricolazioni/">https://www.studenti.unige.it/iscrizioni/preimmatricolazioni/</a> following the pre-enrolment application submitted on the Universitaly portal (deadlines on Universitaly may be subject to change as a result of ministerial provisions). He/she must also contact the Welcome office international students and users email sass@unige.it by 12.00 noon (CEST) on 12 May 2023 to verify the foreign qualification and the terms of payment of the admission fee.
- 2. **The EU and non-EU candidate legally residing in Italy** must submit the application for admission to the competition no later than 12.00 noon (CEST) on **20 July 2023** exclusively through the procedure provided on the University of Genoa's *student portal* https://www.studenti.unige.it/iscrizioni/preimmatricolazioni/.
- 3. **The EU and non-EU candidate residing in Italy in possession of a foreign qualification** must apply for admission to the competition via the *online* procedure described above and also contact the *Welcome office student reception and international users email* sass@unige.it by 12.00 noon (CEST) on **14 July 2023** to verify the foreign qualification.
- 4. At the end of the procedure on the University of Genoa *student portal* the system will issue a receipt to be presented at the examination. This receipt constitutes the only document proving correct registration. After this peremptory deadline, you will no longer be able to register for the competition.
- 5. In order to be admitted to the competition the candidate must pay, under penalty of exclusion from the competition, the contribution for admission to the competition of € 30,00 (thirty/00 Euros), according to one of the methods proposed (https://www.studenti.unige.it/tasse/pagamento online/):
  - by 12.00 noon (CEST) on **18 May 2023** (Non-EU candidates residing abroad)
  - by 12.00 noon (CEST) on the **20 July 2023** (EU and non-EU candidate legally residing in Italy). Payment of the admission fee alone does not constitute registration for the competition. The fee is not refundable except in the case double/incorrect payment is ascertained. Applications for registration to the competition sent by post or other means of transmission will
  - not be accepted.
- 6. Candidates with a certificate of disability or with certification under Law No 104/1992 may make an explicit request, in relation to their individual needs, for specific aids and additional time up to a maximum of 50 per cent more than that defined for the admission test, as well

as further measures to ensure equal opportunities in the performance of the test, in accordance with the Law No 104/1992, ministerial indications and the examining boards. This request must be made when filling in the application form for admission to the competition in the manner specified in the application procedure, no later than 12.00 noon (CEST) on 18 May 2023 (Non-EU candidates residing abroad) and no later than 12.00 noon (CEST) on 20 July 2023 (EU and non-EU candidate legally residing in Italy). In addition, the candidate must enter online, again when registering for the competition and by the above-mentioned deadline, the certification issued by the competent medical commission for the territory attesting to the condition of disability and/or handicap, with recognition of handicap pursuant to Law No 104/1992, for the purposes of assessing the application.

- 7. Candidates diagnosed with specific learning disabilities (DSA) as defined by Law No 170/2010 may make an explicit request for additional time, up to a maximum of 30% more than that defined for the admission test, as well as for additional tools and measures to guarantee equal opportunities in the performance of the test, in accordance with the provisions of Law No 170/2010 and subsequent guidelines, ministerial indications and the examining boards. This request must be made when registering for the competition, no later than 12.00 noon (CEST) on 18 May 2023 (Non-EU candidates residing abroad) and no later than 12.00 noon (CEST) on the 20 July 2023 (EU and non-EU candidates legally residing in Italy), in accordance with the procedures specified in the registration procedure. In addition, the candidate must enter *online*, again when registering for the competition and within the above-mentioned deadlines, the diagnosis of DSA issued no more than three years previously or after the candidate's 18th birthday, issued by local health facilities or by bodies and professionals accredited with the regional health service.
- 8. Candidates may be admitted to the test with the medical certification they possess, even if it is not up-to-date due to the limitation of the NHS for the Covid-19 emergency, subject to the University's right to request the integration of the required documentation at a later date.
- 9. Applicants with invalidity, disability or DSA from EU and non-EU countries, resident abroad, who intend to take advantage of the measures referred to in the previous paragraphs, must present the certification attesting to their state of invalidity, disability or DSA issued in their country of residence, accompanied by a certified or sworn translation by Italian diplomatic representations conforming to the original text, in Italian or English. The University bodies in charge of examining the certifications referred to in the previous paragraphs shall ascertain that the foreign documentation attests to a condition of disability, invalidity or specific learning disorder recognised by Italian law.

# ART. 4 ADMISSION TEST

1. The admission test will be held online and it will take place:

on the **25th May 2023** 

for Non-EU candidates residing abroad

on the **27th of July 2023** 

for EU and non-EU candidates legally residing in Italy

- 2. **Non-EU candidates residing abroad** are summoned on the **25th of May 2023** at 9.00 (CEST) to enable the Committee to carry out the identification operations. The test shall start at 10.00 (CEST).
- 3. **EU and non-EU candidates legally residing in Italy** are summoned on the **27th of July 2023** at 9.00 (CEST) to enable the Committee to carry out the identification operations. The test shall start at 10.00 (CEST).
  - A time of ninety (90) minutes is allocated for the test.
- 4. Candidates must identify themselves by means of a valid identification document, the receipt for the payment of € 30.00 (thirty/00 Euros) and the receipt for the *online* application. Candidates who arrive after the closing of the identification operations will not be allowed to enter the test.
  - Candidates who, for any reason, are absent from the test are considered to have given up.

# ART. 5 HOW THE TEST IS CARRIED OUT - DUTIES OF THE CANDIDATES AND THE COMMITTEE

- 1. The admission test will take place in **telematic mode (online)** with video surveillance. The technical procedures of the test, including the surveillance system, the necessary equipment and the obligation to participate, under penalty of exclusion from the competition, in a technical test on a date prior to the admission test, are indicated in a specific NOTICE published on the degree course website (<a href="https://courses.unige.it/10948">https://courses.unige.it/10948</a>) by the 2nd of May 2023.
- 2. During the test, the candidate may not use any calculating or teaching aids other than those granted as aids to candidates with disabilities or with DSA.
- 3. Any candidate who violates the provisions of the present notice and of the Examination Committee as per art. 7 below, or who in any case has copied the test, even if only in part, will be excluded from the competition.
- 4. The Examination Committee has the right to adopt the necessary measures, also taking into account the provisions of articles 5, 6 and 8 of *Presidential Decree no. 686 of 3 May 1957*.

#### ART. 6

### **TEST CONTENTS AND EVALUATION**

- 1. The test consists of the solution of 50 questions formulated with 4 possibilities of answer, of which the candidate must identify only one, on the following topics:
  - General and maritime culture;
  - Logic and mathematics;
  - Knowledge of the English language.
- 2. On the basis of the programme set out in **Annex 1**, which forms an integral part of this notice, the following will be prepared by the Examination Committee:
  - 10 (ten) questions for general and maritime culture topics;
  - 20 (twenty) questions for the topics of logic and mathematics;
  - 20 (twenty) questions on English language skills.
- 3. For the evaluation of the test, the following criteria shall be taken into account:

1.5 points for each correct answer minus 0.25 points for each wrong answer 0 points for each answer not given

- 4. In the event of a tie, the score obtained by the candidate in the solution of the questions relating to the mathematical arguments shall prevail in descending order. In the event of further parity, the youngest candidate shall prevail. Applicants who have obtained a minimum score of 36 (thirty-six) points in the test are admitted to the next stage of the evaluation of qualifications.

#### ART. 7

#### **EXAMINATION COMMITTEE**

- 1. The Examination Committee is approved by the Departmental Board of the Department of naval, electrical, electronics and telecommunication engineering on the proposal of the *Maritime Science and Technology* Degree Programme Board. The Head of Programme is a member of the Board by right.
  - The Examination Committee is responsible for the proper conduct of the test.
- 2. All the operations carried out by the Examination Committee must be reported in the appropriate minutes, signed by the President and all the members of the Committee, also using digital signatures.
  - In the event of justified necessity, the minutes may be signed only by the President, following a specific and unequivocal declaration of agreement by the other Commissioners, which is an integral part of the minutes.
- 3. In order to ensure that the selection tests are conducted correctly, the Examination Committee may avail itself of the services of special classroom committees composed of teaching and/or technical-administrative staff of the University.

# ART. 8 RANKINGS AND PUBLICATION DEADLINE

1. On the basis of the options expressed and the overall score, obtained by adding the test score and the assessment score, the following merit lists will be drawn up, in which candidates are placed in descending order of marks.

#### ART. 9

#### **ENROLMENT**

- 1. Candidates who have been <u>successfully placed</u> in the respective rankings must enrol by 12.00 noon (CEST) of the **3rd of October 2023**, using <u>only</u> the online enrolment procedure on the <u>Student Portal</u>. <a href="https://www.studenti.unige.it/iscrizioni/preimmatricolazioni/">https://www.studenti.unige.it/iscrizioni/preimmatricolazioni/</a>.
- 2. The application will be valid only if all stages of the procedure have been completed within the deadline set out above, that is:
- selection of the degree course;
- payment of the first instalment of the student contribution consisting of the regional tax and
   € 16.00 euro sixteen/00( for stamp duty);
- in case of application for the ALISEO grant, <u>exclusive</u> payment of € 16,00 euro sixteen/00 (for stamp duty);
- payment of a further € 16,00 € 16,00 (for stamp duty) in case of change of course/withdrawal from studies and payment of any back taxes.

- 3. #### **ANNEX 1**

#### SUBJECTS COVERED BY THE ENTRANCE EXAMINATION

#### General and maritime culture

The questions will focus on knowledge of general and maritime culture. The questions are oriented to verify the basic knowledge about maritime culture and history, with its characters, products, specific events. Questions are in English.

### **Logic and Mathematics**

Verification of the ability to logically complete a reasoning, in a manner consistent with the premises, which are enunciated in symbolic or verbal form through multiple choice questions. For the mathematical part the questions are aimed at ascertaining the mastery of:

- numerical sets and arithmetic calculation (natural, relative, rational, real numbers; ordering and comparison of numbers; order of magnitude; operations, powers, radicals, logarithms), algebraic calculation,
- Euclidean geometry (polygons, circumference and circle, measurements of lengths, surfaces and volumes, isometry, similarities and equivalences, loci),
- Elements of plane trigonometry (sine, cosine, tangent functions and their inverses, fundamental relations of goniometry, formulas for associated angles, theorems for right triangles)

### **English language**

The test is aimed at ascertaining comprehension of the English language.
